

# Resources and Services

The KDCs offer the following services to the public, free of charge:

- Internet access for research purposes
- Use and online access to development-related publications of the World Bank and other established authors
- Access to a catalog that shows the collection of around 60 World Bank public information centers around the world, and which includes downloadable versions of publications
- Free copies of select World Bank publications
- Access to the special collection of CD's and videotapes on development issues

The KDC collection includes not just World Bank materials, but also the publications of other development agencies and works of established authors.

KDCs have resources for persons with disabilities. People who are on wheelchair, have low vision, blind, and deaf can access the center freely. KDCs are equipped with modern assistive equipment and facilities that make access to information easier for persons with disabilities (PWDs) such as:

- Screen magnification for people with low vision
- Books about disabilities
- Track ball mouse for those with psychomotor disabilities
- Braille translator and Braille embosser for the blind
- JAWS software
