


This is organized in two parts, this unique text begins by providing a general introduction to the scientific approach to experimentation. It then describes the processes and tools required, including the relevant statistical and experimental methods. Towards the end of the book a methodology is presented, which leads the reader through the three phases of an experiment: 'Planning', 'Data Collection', and 'Analysis and Synthesis'.

It focuses on general research skills, such as adopting a scientific mindset, learning how to plan meaningful experiments and understanding the fundamentals of collecting and interpreting data. It is directed to anyone engaged in experiments, especially Ph.D. and masters students just starting to create and develop their own experiments.

This is a book for any researcher using any kind of survey data. It introduces the latest methods of assessing the quality and validity of such data by providing new ways of interpreting variation and measuring error. By practically and accessibly demonstrating these techniques, especially those derived from Multiple Correspondence Analysis, the authors develop screening procedures to search for variation in observed responses that do not correspond with actual differences between respondents. Using well-known international data sets, the authors exemplify how to detect all manner of non-substantive variation having sources such as a variety of response styles including acquiescence, respondents' failure to understand questions, inadequate field work standards, interview fatigue, and even the manufacture of (partly) faked interviews.

All social researchers need to think about ethical issues. Their salience has recently been increased by the pressures of ethical regulation, particularly in the case of qualitative research. But what are ethical issues? And how should they be approached? These are not matters about which there is agreement. Ethics in Qualitative Research explores conflicting philosophical assumptions, the diverse social contexts in which ethical problems arise, and the complexities of handling them in practice.

The authors argue that the starting point for any discussion of research ethics must be the values intrinsic to research, above all the commitment to knowledge-production. However, the pursuit of inquiry is rightly constrained by external values, and the book focuses on three of these: minimizing harm, respecting autonomy, and protecting privacy. These external values are shown to be far from unequivocal in character, often in conflict with one another (or with the commitments of research), and always subject to situational interpretation and practical judgment. Nevertheless, it is contended that in the present challenging times it is essential that qualitative researchers uphold research values.

used come from and addresses the problems that arise from deviation from these factors. It also examines the question of what code is best to follow for a specific project: the American code, the British Standard, the Eurocode, or other local codes.

The author devotes an entire chapter to practical statistics methods and probability theory used in structural and civil engineering, both important for calculating the probability of structural failure (reliability analysis). The text addresses the effects of time, environmental conditions, and loads to assess consequences on older structures as well as to calculate the probability of failure. It also presents the effects of steel bar corrosion and column corrosion, and precautions to consider along with guides for design.

This book offers guidelines and tools to evaluate existing as well as new structures, providing all available methods and tests for assessing structures, including visual inspection and nondestructive testing for concrete strength. It also presents techniques for predicting the remaining service life of a structure, which can be used to determine whether to perform repairs or take other action. This practical guide helps readers to differentiate between and understand the philosophy of the various codes and standards, enabling them to work anywhere in the world. It will aid engineers at all levels working on projects from the design to the maintenance phase, increasing their grasp of structure behavior, codes and factors, and predicting service life.






